Violation of this agreement will lead to immediate termination of access as well the Republican National Committee (RNC) and/or Illinois Republican Party (IRP)'s right to seek injunctive relief and/or monetary damages.*

By signing below, I agree to limit my use of this voter information to political purposes only. In addition, I agree that under no circumstances will I use this information for commercial purposes. I further agree that I will utilize this information for political purposes under a program authorized by the RNC and IRP and will not use this information to support or assist the candidacy of any non-Republican candidate for office in any jurisdiction or any non-Republican political organization. In addition, I agree to share information that I enter into Voter Vault with the RNC, IRP, and authorized users of Voter Vault. I agree that I will not permit the use or copying of the voter information by any person not working under the direction of the RNC and IRP. I agree that I will also not enter any information in Voter Vault that I know to be false or alter existing information in a deliberately false manner. I also agree that user passwords are not to be shared with other users and that passwords may only be distributed by the IRP. I also agree that if my designation as - or affiliation with - an authorizing Republican chairman/committeeman, officeholder or candidate changes or ceases to exist, it is my obligation to notify IRP and my access will be terminated.

If I am (or designee of) a candidate in a contested Republican primary election or am a member of or authorized user from a Republican organization supporting a candidate in a contested Republican organization, then I agree to enter all voter data accumulated during the primary campaign immediately following Primary Election Day, regardless of the outcome of the Primary Election. If I am (or designee of) a candidate in an uncontested Republican primary election and/or a General Election or am a member of or authorized user from a Republican organization supporting a candidate in an uncontested Republican primary, then I agree to enter accumulated voter data as it is gathered.
